Purpose of the Community Sponsorship Program

- Our Community Sponsorship Program offers organisations and groups the opportunity to access financial assistance and in-kind contributions to support events and programs that benefit the community.
- Origin's Community Sponsorship Program aims to add value to community activities that make a positive contribution to one or more of the following areas:
- · Economic development:

Supporting local supply, capacity building, Indigenous participation, innovation and training initiatives.

· Natural resource stewardship:

Partnering for environmental sustainability, water quality, revegetation and biosecurity.

· Community safety and wellbeing:

Celebrating diversity, promoting inclusiveness and community cohesion, sporting and cultural events.

· Regional growth & liveability:

Enabling and supporting education, community connectedness and resilience.

Origin will consider supporting (inclusions)

- Projects and organisations that benefit communities in which we operate. This includes the local government areas of Maranoa Regional Council, Western Downs Regional Council & Banana Shire Council
- Events or activities run by registered charities and/or not-for-profit organisations
- Projects which align to one or more of the priority areas listed above
- · Projects that are inclusive and have good "community reach"
- · One-off social/community events or fundraisers.

Origin will generally not support (exclusions)

- · Individual teams and/or individual participants in an event
- · Past events or projects
- · Political organisations or campaigns
- · Religious organisations for religious activities
- · An organisation's ongoing operational costs
- · Activities which encourage the irresponsible use of alcohol
- · Activities which encourage gambling
- One-off donations to the same organisation more than once per year
- · Activities which are usually exclusively funded by government
- Activities which provide a direct financial benefit to Australia Pacific LNG or Origin employees or contractors
- Activities where there is an unmitigated risk to animal welfare or where there are no animal welfare guidelines available from an Origin-approved advisory body in relation to the activity.

Closing dates for funding rounds are:

- 31st January, 30th April, 31st July and 31st October each year.
 * Applicants will be notified of their application result within 45 days of the close of each round
- If an application form is submitted after the funding round closing date, it will be assessed in the next round.
